

# Market Analysis

# Market Validation

The goal of Market validation is to **test assumptions** about the technology by gathering real feedback from potential customers/industry experts (or academic/regulatory experts). This helps **refine the technology to ensure it meets real market needs before full development.**

We use semi-structured interviews to focus on **understanding the customer's real problems and needs**, not just whether they like the technology.

# Intellectual Property Valuation

Our IP Valuation service helps technology owners, research institutions, startups, and investors **understand the true economic potential of their intellectual property**. We evaluate intellectual property, typically patents or other intangible assets.

Our valuation is based on the income approach, meaning **we assess its real market potential**.

**The result is an official valuation report, certified** by a court-appointed expert. This gives your innovation a clear and objective market price tag.
